

CALL FOR APPLICATIONS FOR THE RECRUITMENT OF AUDITORS - CONSULTANTS

- ✓ Evidence of financial capacity to pay for training costs.

Training costs: 975 000 CFAF (payable in two installments maximum: at registration and after three months of training)
